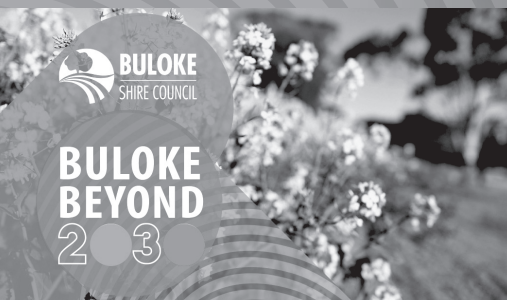

Spinning Around

Works to bring the Wycheproof turntable to an operational standard were completed in late February.

The team at Steam Rail Victoria prefabricated the materials needed for the job at their Newport workshop to ensure a 'quick turnaround'.

Council are negotiating with Steam Rail Victoria to lease the Council-owned railway turntable, whilst still allowing other rail operators to use the facility, to full realise the potential of rail based tourism into the future.

Council has also in the past advocated to the State Government to include the turntable and approach track in any works to standardise the Sea Lake line and will continue to advocate for this project.

Council would commit to working with Steamrail Victoria to seek State and Federal grants to assist with the development of this initiative.

Another Our Region-Our Rivers Project Begins

The Donald Riverfront Project has commenced! The \$717,000 project is funded by the Federal Government's Regional Growth Fund (Our Region-Our Rivers), Council and the community and will transform the Bullocks Head viewing area along the Richardson River.

The area will be closed to the public as works begin to construct a new viewing platform, sheltered seating area, lighting, electric BBQ and landscaping. Look out for traffic management in place at times along Byrne Street during the construction period.

Notice of an Application for a Planning Permit

The land affected by the application is located at **76-78 Mount Street, Wycheproof**.

The application is for a permit for a **two lot subdivision of land**.

You may look at the application and any documents that support the application by making contact with the office of the Responsible Authority, **Buloke Shire Office, Wycheproof**.

This can be done during office hours and is free of charge. Any person who may be affected by the granting of the permit may object or make other submissions to the Responsible Authority.

An objection must be sent to the Responsible Authority in writing, include the objectors name and contact details, include reasons for the objection, and state how the objector would be affected. An objection form is available on the Planning and Building page of the Buloke Shire Council website.

The Responsible Authority will not decide on the application before **18 March 2021**.

If you object the Responsible Authority will tell you its decision.
