COVID-19 Update

Victoria is experiencing a spike in COVID-19 cases. Whilst this is largely confined to metropolitan areas, we must recognise that this isn't over and do our part. If you are showing any symptoms, no matter how mild, get tested.

Local testing is available in Buloke.

If you are demonstrating symptoms, please ring ahead to your health service campus or GP to discuss the best way to access testing.

Both East Wimmera Health Service (Donald, Charlton, Birchip, Wycheproof) and Mallee Track Health and Community Service (Sea Lake) continually update testing information through their newsletters, media and social media.

If you have symptoms, make a call, get tested and help keep Buloke safe.

Council's Universal Maternal and Child Health (MCH) Program has resumed full operation. All scheduled Key Ages and Stages bookings can be made by contacting your usual nurse or 1300 520 520.

Please note that social distancing is to be observed at all times and a risk assessment will be required to be completed before face to face consultations are conducted.

As we reinstate some facilities and services minimising disruption is a high priority, second only to the health and wellbeing of the community. Notice of an Application for a Planning Permit

The land affected by the application is located at 18 Johnson Street, Birchip.

The application is for a permit for the construction of a dwelling in a Heritage Overlay.

The applicant for the permit is Dean Rickard.

The application reference number is PPA 867/20

You may look at the application and any documents that support the application by making contact with the office of the Responsible Authority, **Buloke Shire Office, Wycheproof.**

This can be done during office hours and is free of charge. Any person who may be affected by the granting of the permit may object or make other submissions to the Responsible Authority.

An objection must be sent to the Responsible Authority in writing, include the objectors name and contact details, include reasons for the objection, and state how the objector would be affected. An objection form is available on the Planning and Building page of the Buloke Shire Council website.

The Responsible Authority will not decide on the application before 23 July 2020.

If you object the Responsible Authority will tell you its decision.
