### **Wycheproof** Wetlands

Council has received a grant from the Victorian Government to help develop the Wycheproof Wetlands Precinct.

The precinct builds upon the recently completed Wycheproof Recreation Reserve Master Plan, to enhance existing tourism opportunities; provide new recreational activities for the wider community; and also provide valuable habitat for birds, fish, insects and amphibians.

If you want to know more about the Wycheproof Wetlands proposal, come along to a community meeting where opportunities about possible inclusions in the proposal will be discussed, such a skate park or pump track, play area, walking trails, jetty or swimming pontoon, barbecue area and landscaping.

Council is seeking input from the community into the final design of planned infrastructure at the site.

### Parking Heavy Vehicles

Across Victoria, trucks, or heavy vehicles, are restricted in how long they can be parked within a township area.

Township areas are described, by definition, as a built-up area and these rules are in place to prevent the amenity of an area being affected. The rules are enforceable at both a state and local level:

Under the State road rules, rule 200(2), the driver of a heavy (4.5T GVM) or long vehicle (over 7.5m) must not stop on a length of road in a built-up area for longer than one hour, unless they are loading or unloading.

Locations where long and heavy vehicles are

- Sea Lake Calder Hwy, south of township (near old Roadhouse):
- Donald Racecourse Rd;

permitted to park in townships:

- **Birchip** Berriwillock Rd, off Birchip-Berriwillock Rd (near old truck wash);
- Charlton Boort Rd (near substation); and
- **Wycheproof** alongside Saleyards (not near ramp).

#### Sea Lake Drainage

Contractors are updating the footpath crossing at Cunningham Lane at Sea Lake, now that the weather is more favourable, requiring the closure of Cunningham Lane to Best Street for two weeks.

Preparations began on 2 November for excavation, base preparation and boxing work ahead of concrete pouring.

For the safety of the community and contractors, half of the lane will remain closed whilst heavy machinery is being used.

The entrance to parking at the hotel via Cunningham Lane will remain open.
