## Planning and Environment Act 1987

### Buloke Planning Scheme - Notice of Approval of Amendment - Amendment C42

The Minister for Planning has approved Amendment C42 to the Buloke Planning Scheme.

The Amendment comes into operation on the date this notice is published in the Victoria Government Gazette.

The Amendment applies to various parcels of public and privately owned land within the Buloke Shire. The Amendment proposes to delete the Environmental Significance Overlay, schedule 2 (ES02) Channel and Reservoir Protection from all locations throughout the Buloke Shire Council as the objectives and purposes of this overlay are now redundant.

## Notice of an Application for a Planning Permit

An objection must be sent to the Responsible Authority in writing, include the objectors name and contact details, include reasons for the objection, and state how the objector would be affected. An objection form is available on the Planning and Building page of the Buloke Shire Council website.

The Responsible Authority will not decide on the application before **15 April 2021.**

If you object the Responsible Authority will tell you its decision.
