POSITION OBJECTIVE:

• To assist children to travel to and from schools in the Municipality and reduce their risk of being involved in accidents with any vehicles.

KEY RESPONSIBILITIES AND DUTIES:

- Operate the school crossing in accordance with the 'Instructions for Children's Crossing Supervisors as prepared by the Victorian Police and Vic Roads.
- Ensure that it is safe to cross before allowing any person onto the crossing.
- Ensure that all pedestrians have crossed the roadway before vacating the crossing.
- Maintain Vigilance, professional behaviour and conduct at all times.
- At crossings at the appropriate time, stop traffic when safe to do so and direct the flow of pedestrians in accordance with issued instructions.
- Wear issued uniform and utilise safety equipment at all times when on duty.
- Report to Shire Officers any inappropriate parking practises or similar concerning practices by vehicles or persons
- Make recommendations to the Team Leader of Compliance on matters which may improve safety at school crossings.

- Children's Crossing Supervisors are to carry out their duties in accordance with VicRoads Guidelines and instruction for Children's Crossing Supervisors, the provisions of the Road Safety Act 1986 and any legislation made thereunder, together with any directive from their supervisor.

JUDGEMENT AND DECISION MAKING:

• Works to defined School Crossing procedures. May vary procedures may vary in an emergency to ensure public safety.

SPECIALIST SKILLS AND KNOWLEDGE:

- A clear understanding of the role and purpose of a Children's Crossing Supervisor.
- A working knowledge of the road laws and Council processes.
