

HARD WASTE TRIAL

During June 2026, Council is trialing a new Hard Waste Collection service. This trial will initially be available to Buloke Shire residents in the townships of Berriwilllock, Nandaly and Sea Lake.

Where is this happening?

The trial will happen in the townships of Berriwilllock, Nandaly and Sea Lake. Only residents who live on streets within the township are eligible for this initial trial.

When is the trial service?

Items will be collected between 8am on Monday 15 June and 5pm on Friday 19 June. Residents will be able to place items at kerbside for collection from 8am on Friday 12 June.

What items will be accepted?

Mattresses (one per household), furniture, E-waste items, and metal or white goods will be accepted.

Is there a limit on how much I can leave for collection?

Yes. Each household can place up to 3 cubic metres of waste (approximately 3m long x 1m wide x 1m high).

A limit of one mattress per household also applies.

NOTICE OF AN APPLICATION FOR A PLANNING PERMIT

The land affected by the application is located at **376-388 Broadway, Wycheproof.**

The application is for a permit for **building and works to construct a 13m x 11m garage.**

The application reference number is **PA26015.**

This can be done during office hours and is free of charge. Any person who may be affected by the granting of the permit may object or make other submissions to the Responsible Authority.

An objection must be made to the Responsible Authority in writing, include the objector's name and contact details, include reasons for the objection, and state how the objector would be affected. The Responsible Authority will not decide on the application before **25 June 2026.**

If you object to the application, the Responsible Authority will tell you it's decision.
