BIRCHIP SKATEPARK UPDATE

The half pipe at the Birchip Skatepark will be temporarily removed to allow for essential repairs to be assessed.

Recent inspections identified holes in the surface of the equipment, making it unsafe for use until necessary works are completed.

While the half pipe is out of action, all other skatepark facilities remain open and available for community use.

Council will continue to monitor the situation and provide updates as the assessment and repair process progresses.

BULOKE SHIRE COUNCIL NOTICE OF AN APPLICATION FOR A PLANNING PERMIT

The land affected by the application is located at **407 Walsh and Arnolds Road, Culgoa.**

The application is for a permit for a **two lot subdivision of land (boundary realignment).**

The application reference number is **PA26016.**

This can be done during office hours and is free of charge. Any person who may be affected by the granting of the permit may object or make other submissions to the Responsible Authority.

An objection must be made to the Responsible Authority in writing, include the objector's name and contact details, include reasons for the objection, and state how the objector would be affected. The Responsible Authority will not decide on the application before **2 July 2026.**

If you object to the application, the Responsible Authority will tell you it's decision.
