**State Government Levy**

The fee payable includes a State Government levy of \$4.23 for each animal being registered and is primarily used to fund responsible pet ownership educational programs conducted by State Government.

**Microchipping**

All dogs and cats being registered with Buloke Shire Council must be microchipped and a certificate of proof is required. Only dogs or cats that are subject of written veterinary advice stating the health of the animal is liable to be significantly prejudiced if implanted with a microchip will be exempt from the requirement to microchip.

**Reduced Fee**

Applies to animals that are (proof required):

- Desexed
- Working dog: *Dogs of a recognised working dog breed regularly used for the movement of livestock* (proof of work aptitude may be required)
- Over 10 years old
- Guide dog, racing dog, police dog

**Excess Animal Permits**

Buloke Shire Council's Local Law requires a permit to be obtained to keep more than two dogs and/or two cats in a township area and five dogs and/or two cats outside a township area. An Application for Permit - Excess Animals form will need to be completed if you exceed these limits.

**Change of Details**

You must complete a change of animal details form if:

- You sell or give away your pet
- Your pet has been desexed or microchipped
- Your pet is now deceased

**Change of Ownership**

If you have purchased an animal from another person they will need to complete a change of ownership with the National Pet Register 1300 734 738.
