Sea Lake Streetscaping

Works to upgrade footpaths, irrigation, landscaping, kerbing, seating and electrical lighting at Apex Park have been delayed due to a shortage of suitably skilled tradespeople. As work had commenced it was necessary to maintain restrictions to park access, for community safety.

With activity expected to resume next week, the toilet facility in Apex Park may not be accessible at some times from Best Street, however Howard Lane access will be maintained. The Sea Lake Visitor Information Centre facilities will also remain open.

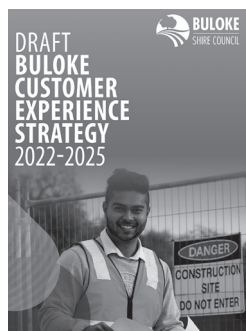
