Any person who wishes to be heard in support of their written submission must request this in their submission. Such persons will be entitled to appear in person or by a person acting on his or her behalf before the Council meeting where submissions will be heard. This will be a part of the Ordinary Meeting of Council to be held at 7.00pm on Wednesday 10 June 2020. This meeting will either be held in the Wycheproof Supper Room or online.

Around the Towns

Tree Works to Commence

There will be some tree programs being undertaken from June in two towns across Buloke.

There will be extensive work undertaken in Centenary Park, Wycheproof on a number of trees to prolong the health of some existing trees as well as some risk minimisation treatments on some of the larger specimens in the park.

The second stage of the Beautify Charlton Project will also commence along Mildura Way in the middle of June.

The next stage involves removing Desert Ash trees and replanting with Ornamental Pears. Council will continue working closely with the North Central Garden Club on the project with the new trees expected to be planted in mid-July.



Playground Upgrades Continue

The upgrade to Soldiers Memorial Park playground in Culgoa has been completed!

New swings and softfall have given the playspace a wonderful lift.

Similar works will begin shortly in Watchem Park and are expected to be completed by the end of June.

Playgrounds have reopened across Buloke after some easing of COVID-19 restrictions. Remember to practise good personal hygiene and social distancing if you choose to attend.

New Pool and Spa Regulations

Have you got a backyard pool or spa?

Pool and spa owners are required to register pools or

spas with their local Councils.
This was initially to be done by 1 June 2020, but has been extended to 1 November 2020. The new deadline is an acknowledgement of the extra burden currently on families and on Councils.

These new laws have been introduced to keep young

In addition, owners will be required to engage a registered building surveyor or building inspector to inspect and certify the compliance of their safety

barrier every four years.
