Whilst the metropolitan area and Mitchell Shire are locked down for the next period, we in Buloke need to remain committed to our community's wellbeing.

We know most people want to do the right thing and protect each other. While we would love to see the place buzzing with eased restrictions, we have to be mindful that here in Buloke our average age of residents is 51 and close to 30% of our population is aged over 65.
