Recent easing of some restrictions means that our Recreational Lakes are now open for things like boating, fishing, kayaking and walking.


Some outdoor sporting activities are also permitted. They must be non-competition based and non-contact.

Submissions

Community members are welcome to make a written submission on the proposed Budget in accordance with Section 223 of the Act. Submissions should be addressed to the Chief Executive Officer, Buloke Shire Council, P.O. Box 1, Wycheproof, 3527. Submissions must be received no later than 5.00pm Wednesday 10 June 2020.

Any person who wishes to be heard in support of their written submission must request this in their submission. Such persons will be entitled to appear in person or by a person acting on his or her behalf before the Council meeting where submissions will be heard. This will be a part of the Ordinary Meeting of Council to be held at 7.00pm on Wednesday 10 June 2020. This meeting will either be held in the Wycheproof Supper Room or online.

Meeting to adopt the budget

Council's Annual Budget 2020/21 will be adopted at a Special Meeting of Council to be held at 6.00pm on 17 June 2020. This meeting will either be held in the Wycheproof Supper Room or online.

Lights, Camera, Action on Broadway Show

It was announced last week that the Wycheproof Streetscape had received a funding boost from the State Government's Regional Infrastructure Fund of \$450,000 for the Brightening Broadway Project. The project, worth \$600,000 is also funded by Council (\$150,000) and will give Broadway a huge lift in attraction, amenity and accessibility.

One of 35 projects from across rural and regional Victoria to share in the funding, the streetscape project involves developing a Civic Park between the Council Offices and Senior Citizens Building, Long Vehicle parking spaces, footpath replacements, pedestrian crossings, seating, car charging point, lighting and an art installation.

Notice of an Application for a Planning Permit

The land affected by the application is located at **1 M Keanes Road, Wycheproof.**

The application is for a permit for a **second** dwelling on a lot.

The applicant for the permit is **DA & LM Broad.**

The application reference number is **PPA 860/20.** You may look at the application and any documents that support the application by making contact with the office of the Responsible Authority, **Buloke Shire Office, Wycheproof.**

This can be done during office hours and is free of charge. Any person who may be affected by the granting of the permit may object or make other submissions to the Responsible Authority.

An objection must be sent to the Responsible Authority in writing, include the objectors name and contact details, include reasons for the objection, and state how the objector would be affected. An objection form is available on the Planning and Building page of the Buloke Shire Council website.

The Responsible Authority will not decide on the application before **4 June 2020.**

If you object the Responsible Authority will tell you its decision.
