COVID-19 Update

It's a different time, and yes there is some apprehension around visitors to our region.

Metropolitan Melbourne and Mitchell Shire are currently in Stage 3 "Stay at Home" restrictions.

Victoria Police are doing all they can to ensure people are following these directions and cracking down on deliberate breaches. The State of Victoria is actively responding to increasing rates of COVID-19.

Understandably, we are receiving reports from the community anxious about rumoured positive cases. When a case is confirmed, it is handled by The Department of Health and Human Services, the Department follows up the contact tracing through the thorough State-led response.

At this point, there are no confirmed reports of any active cases in Buloke. However, the message is clear that we shouldn't be waiting for the first active case to change our behaviour. We must continue to follow the guidelines — keeping 1.5 metres between ourselves and others, practicing good hand hygiene, staying home if you feel unwell and getting tested if you are showing any symptoms.
