The Paddock: The Goals is fully on AIR!



Duck Hunting - Wooroonook

Attention all hunters! As the duck hunting season approaches, we want to remind you that shooting on Wooroonook Lake is strictly prohibited this season. It is important that we all follow the regulations and restrictions in place to protect the environment, wildlife, and ensure the safety of everyone involved. However, if you're looking to hunt in the area, you may consider the East and Middle Lakes as alternative hunting spots. These areas are open for hunting during duck season, so you can still enjoy your hunting activities while adhering to the rules and regulations.

Wooroonook Lake is Open!

We're happy to let you know that Lake Wooroonook is open for use once again! As of April 6, 2023, the lake has been fully reopened following a temporary closure due to a blue-green algae outbreak. We thank the community for their patience and we are sure everyone is looking forward to getting back out and using Wooroonook to its full potential!

Support for Business

Support is available for flood-affected businesses to assist them in their recovery, including up to \$50,000 grants, financial counselling and advice, and mental health and wellbeing support.

- Grants up to \$50,000 to help businesses, not-for-profit, and community sport organisations that have experienced direct damage to their property, assets, stock or equipment due to the Victorian floods will close at 4pm on Monday 1 May 2023.
- Eligible businesses, not-for-profit, and community sport organisations must be located within a local government area declared under the Disaster Recovery Funding Arrangement (defined disaster area).
- Immediate support, information, advice, and assistance with application processes, can be found through a Business Relief Adviser. You can submit a registration form online or call the Business Victoria hotline on 13 22 15.
- The Business Relief Service has advisers that can help you connect with relevant support services, assist with grant applications, and help you with your next steps towards recovery.
