### **Council** Works

Works to rejuvenate the Scilley's Island footbridge in **Donald** have commenced. The popular access point to the Federation Walking Track across the island and around the football ground was closed in June 2020 for community safety.

Work is now underway to prepare the bridge for new deck planks and handrailing that is being fabricated locally. The expected completion of the construction is 30 October 2022, and once approved the new structure should be open to the public in November.



The 30-metre-long curving span rises two metres, and was designed by the engineering department of the Donald Shire and fabricated by the Bendigo Ordnance Factory back in 1980. Following the Scilley's Island works, the **Watchem** Hall improvements will commence. Permits will soon be issued for construction of a disabled access ramp from the carpark and repairs to the south wall. Access is expected to be limited to the front entrance for up to four weeks. Council will advise when works are imminent.
