
# **Community** Update

## **Registrations** Pools and Spas

A reminder to residents with swimming pools and spas that the due dates for lodging Pool and Spa Certificate of Barrier Compliance now apply for pools and spas built:

- without a building permit, lodgement is due now
- on or before June 30, 1994, lodgement is due now
- between 1 July 1994 and 30 April 2010, lodgement by 1 June 2023
- built on or after 1 May 2010, lodgement by 1 June 2024.

Pool and spa owners must have a registered building surveyor or inspector certify their safety barrier every four years and lodge a Certificate of Barrier Compliance with Council.

### Have Your Say - Asset Plan

The Local Government Act 2020 requires Council to develop an Asset Plan to clearly and transparently set its direction and priorities which support the efficient and responsible management of its assets on behalf of the community.

The purpose of the plan is to provide an overview of Council's fixed assets, the strategic challenges it faces in their responsible management, and the longer-term strategies Council is pursuing over the next decade.

Major assets maintained by Council include a road network of 5,302 kilometers and 240 buildings and structures with a replacement value of \$113M.

# **Notice of an Application** for a Planning Permit

The land affected by the application is located at **100 Horace Street, Sea Lake.** 

The application is for a permit for a **solar PV installation**.

The application reference number is **PPA983/22**.

You may look at the application and any documents that support the application on the **Buloke Shire Council website** or by making contact with the office of the Responsible Authority, **Buloke Shire Office**, **Wycheproof**.

This can be done during office hours and is free of charge. Any person who may be affected by the granting of the permit may object or make other submissions to the Responsible Authority.

An objection must be sent to the Responsible Authority in writing, include the objectors name and contact details, include reasons for the objection, and state how the objector would be affected. An objection form is available on the Planning and Building page of the Buloke Shire Council website.

The Responsible Authority will not decide on the application before **23 June 2022**.

If you object the Responsible Authority will tell you its decision.
